Recovery for pure economic loss in English law, arising from negligence, has traditionally been limited. Notably, recovery for losses that are "purely economic" arise under the Fatal Accidents Act 1976; and for negligent misstatements, as stated in *Hedley Byrne v. Heller*. Economic loss generally refers to financial detriment that can be seen on a balance sheet but not physically.
